Call For KAHSA 2007 Awards Nominations

NOTICE - Any person working in a KAHSA member home may make a nomination, not just administrators and managers. Please take the time to nominate that worthy person(s) in your facility. Nominees should be persons/groups who have NOT received a KAHSA award in the past 2 years.

Outstanding Board Leadership Award

This award recognizes the achievement/leadership of an outstanding member of the Board of Directors of a KAHSA member home. This individual's service should exceed expectations for commitment of time and effort on Board work and should have earned wide respect from Board and management.

Criteria: An individual whose service demonstrates exemplary Board Leadership including successful application of personal knowledge, insight, courage, influence, interpersonal and team-building skills to the facility's needs.

Candidates: Current or retired board member who may, or may not, have been a board officer.

Outstanding Service Award

This award is presented to any person in any position of the following categories of a KAHSA Facility who has rendered unique service contributions beyond their job requirements to the facility and/or residents:

Criteria: An individual whose service goes beyond assigned duties to enhance the quality of life for residents.

Candidates: This award is available to all levels of member facility employees in all departments.

KAHSA Outstanding Community Service Award

This award recognizes the achievements of an association member or non-member who has made an outstanding contribution toward the welfare of residents in such areas as, but not limited to, research, education, communications, public policy or innovative programs.

Criteria: A history of commitment and involvement which has produced understanding, knowledge, service and / or public policy which benefits residents of KAHSA member homes.

Candidates: Any individual, KAHSA member or non-member.

Outstanding Volunteer Award

This award is presented to a group or individual, resident or community volunteer (adult or youth) of a KAHSA member home who has performed significant volunteer service to residents, and who has demonstrated unusual commitment to preserve the dignity, well-being and independence of residents.

Criteria: Meaningful contributions, on a volunteer basis, to the enrichment of the home's residents.

Candidates: Any individual or group volunteering service to a KAHSA member home.

Innovation of the Year Award

This award is presented to the KAHSA member who has developed a program, technique, or design that improves the quality of service or demonstrates creative problem solving that benefits residents, clients or facility.

Criteria: Originality and creativity of the program or technique, proven benefits to residents, clients, or facility and potential for application to the needs of other organizations or facilities.

Candidates: Any KAHSA member.

KAHSA Bell Leadership Award For Excellence in Health Care

The KAHSA Bell Leadership Award honors individuals with attributes akin to its namesake, Deborah C. Bell. Ms. Bell's endeavors, driven by a fierce determination to make a difference, resulted in her ultimate goal, raising the standard of medical care and service to the elderly. The KAHSA Bell Award epitomizes what is and will be the best within our profession.

Criteria: This award is given to an individual who possess attributes related to dynamic and seasoned leadership, distinguished service in long term care, integrity and character, passion for the elderly, enthusiasm to inspire excellence in others, superior intellect and decision making skills and significant contribution to the long term care profession.

Candidates: Any individual, KAHSA member or non-member.
